

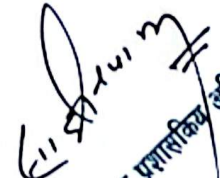

Chhatradev Rural Municipality invites bids (Hard Copy) from Nepalese eligible bidders for the construction of **Lakuri Kharka-Sikhre-Kavre-Ripa Motorable Road Upgrading Works, Chhatradev-2** under National Competitive Bidding procedures. The estimated amount for the works is NRs. 1,07,89,909.32 (Excluding VAT & Contigencies).

4. Pre-bid meeting shall be held at Chhatradev Rural Municipality at 13:00 Hrs 2083/06/14 BS (30th September, 2026).
5. Sealed bids must be submitted to the office Chhatradev Rural Municipality by hand/courier on or before 12:00 Hrs on 2083/06/22 BS (08th October, 2026). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:15 Hrs, 2083/06/22 (08th October, 2026) at the office of Chhatradev Rural Municipality. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security amounting to a minimum of NRs. 3,03,000/-, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days from date of opening)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
