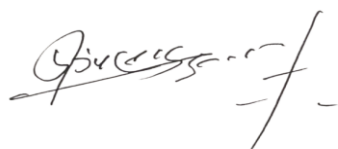

The **Galchhi Rural Municipality** has allocated funds towards the cost of **Nibuwabote Tinghare Chaipur Ramche Road Upgradation Wada No. 08** and intends to apply part of the funds to cover eligible payments under the Contract **for GRM/WORKS/NCB/083-84/1S2E/03** Bidding is open to all eligible as per Section V of bidding document.
2. **Galchhi Rural Municipality, Baireni, Dhading** invites sealed bids or electronic bids from eligible bidders for the **Nibuwabote Tinghare Chaipur Ramche Road Upgradation Wada No. 08** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

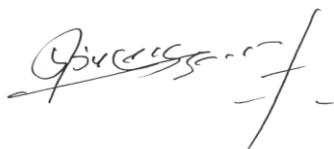
- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRS 2,91,00,000.00**
 - Minimum Work experience of similar size and nature: One Road Project with Value **NRS 78,00,000.00**
3. Bidder shall submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

 5. Bidder shall submit their bid electronically and they may download the bidding documents for e-submission from PPMO's e-GP system **www.bolpatra.gov.np/egp**.
 6. Pre-bid meeting shall be held at **Office of Galchhi Rural Municipality at 24th August 2026, 13:00 hrs.**
 7. Electronic bids must be submitted through PPMO's e-GP system **www.bolpatra.gov.np/egp** on or before **12:00 Hrs on 05th of September, 2026**. Bids received after this deadline will be rejected.
 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs, 05th of September, 2026** at the office of **Galchhi Rural Municipality, Baireni, Dhading**. Bids must be valid for a period of **90 days from the bid submission deadline** and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRS 5,00,000.00** which shall be valid for 30 days beyond the validity period of the bid
