4. Pre-bid meeting shall be held at *Benighat Rorang Rural Municipality, Bishaltar, Dhading* at 2083-06-08, 13:00 hours.
5. Sealed bids must be submitted to the office *Benighat Rorang Rural Municipality, Bishaltar, Dhading* on or before 12:00 noon on 2083-06-16. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2083-06-16 at the office of *Benighat Rorang Rural Municipality, Bishaltar, Dhading*. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security original copy of the bid security amounting to a minimum of Rs. 5,00,000.00 which shall be valid for 30 days beyond the validity period of the bid (*i.e. 30th January, 2027(2083/10/16)*).
7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
