1. **Dhunibeshi Municipality, Dhading** invites electronic bids from eligible bidders for the construction of **Dovan Tinchhange Likhu Toplang (Viewtower) Pakki Sadak ward no 7** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [NRs 3,89,00,000.00]
 - Minimum Work experience of similar size and nature: *At least one contract with the value of at least NRS:- 1,03,83,000.00*
2. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

5. Pre-bid meeting shall be held at **Dhunibeshi Municipality, Dhading** at 18th Bhadra 2083, 13:00.
6. electronic bids must be submitted to the office **Dhunibeshi Municipality, Dhading** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 30th Bhadra 2083. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 30th Bhadra 2083 at the office of **Dhunibeshi Municipality, Dhading**. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum NRS:- 7,50,000.00 which shall be valid for 30 days beyond the validity period of the bid
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
